

ARTICLES OF INCORPORATION
OF
CALIFORNIA FOUNDATION FOR EXCELLENCE IN PODIATRIC MEDICINE

ARTICLE I

The name of this corporation is California Foundation for Excellence in Podiatric Medicine.

ARTICLE II

A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. The specific and primary purpose of this corporation is to engage in charitable and educational activities within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States internal revenue law (the "Code"), by providing funds and support for the field of podiatric medical education and care in California.

ARTICLE III

A. This corporation is organized and operated exclusively for exempt purposes within the meaning of Section 501(c)(3) of the Code. Notwithstanding any other provision of these Articles, this corporation shall not carry on any activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (2) by a corporation, contributions to which are deductible under Sections 170(c)(2), 2055(a)(2), 2106(a)(2)(A)(ii), 2522(a)(2), or 2522(b)(2) of the Code.

B. Except as permitted by law, no substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE IV

The property of this corporation is irrevocably dedicated to charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member, if any, of this corporation, or any other private person. Upon the winding up and dissolution of this corporation and after paying or adequately providing for the debts and obligations of this corporation, the remaining assets shall be distributed to Samuel Merritt University, a California nonprofit public benefit corporation, a foundation affiliated with the California state podiatric medical association, or another nonprofit fund, foundation, or corporation that is organized and operated exclusively for charitable purposes and has agreed to comply with all charitable trust restrictions applicable to the assets and to use the assets to fund and support podiatric medical education and care in California, and that has established its tax-exempt status under Section 501(c)(3) of the Code.
